*Practices in Research* is an annual online open access double blind peer reviewed journal for practice-based research in architecture. The publication is articulated to an annual conference for practice-based research in Architecture with the same name. The journal invites practising architects to explore the relationships between their practice and their research. The focus on the relationship of architectural practice and research can lead to a broad range of contributions, such as considerations about specific design processes, transversal surveys, epistemologic reflections, considerations about tools and media.

# Peer review process

The editorial team of Practices in Research ensures the quality of the editorial standard.

1. An open call for contributions is issued for each issue including the instructions for the authors. The call may be combined with invited contributions.
2. The editors decide if the contribution falls within the scope of the journal and are suitable for inclusion in the issue.
3. Accepted contributions then undergo a double-blind peer-review process. The editors select two independent experts to review the submission.<sup>1</sup> Anonymity is strictly maintained and all information in the paper that identifies the author is removed<sup>2</sup>. The anonymity of the reviews is also ensured. The reviews investigate the scientific rigor, the artistic quality and the clarity of communication of the contribution. It also involves an open comment on the contribution.
4. If accepted (no negative review), the author is asked to resubmit the contribution following the reviews and editorial comments. The editorial team makes the final decision on whether the submission is rejected or accepted.

1. The reviewers are members of the scientific committee. Additional experts may be invited to review the contributions.

2. The editorial board acknowledges that the work of the involved practices may benefit from public recognition in the professional or cultural field through prizes, exhibitions, lectures, etc. The anonymity of the contribution does not address the practice itself but the authors of the contribution.

Practices in Research is open to all proposals for guest-edited special issues, provided they follow the general thematic orientation as well as the general peer-reviewed policy of the journal.
